Proposal to Go Back to Areas:

Proposal Number: 2025-01-03

Maker: First Coast Area & HRP

Proposal: To eliminate the Florida Service Symposium as an FRSC hosted event. For the Florida Regional Service Committee to no longer host the Florida Service Symposium and to remove all references in the Guide to Florida Regional Service.

Intent: To let go of the FSS with the hopes that this would allow the Southeast Zonal Forum or another Region/Zone to assume the hosting responsibilities for this event as this will free up a large portion of our funds.

Rationale: The Florida Regional Service Committee inaugurated the Florida Service Symposium in 2005 and has hosted this event every other year since. Except for 2021 all were held in person. The event has always been provided to members at no cost. We have interacted directly with the medical field, treatment industry, the Department of Corrections, Law Enforcement, the legal system, and government officials to name a few. The Florida Service Symposium was the first event of its kind, attracted NA members from around the world, brought trusted servants of our fellowship together from coffee makers to World Board members. For 20 years the Florida Service Symposium has continued to fulfill its goal of becoming a primary model for trusted service training and all

levels of service by providing cutting edge training not typically found elsewhere in our fellowship; communicating NA World Service strategic plans, initiatives, and current projects. We have fulfilled our mission and become a model for similar events now active throughout the world. Because there are now several similar events presented by adjacent zones, the Florida Service Symposium is no longer a priority event for the World Board and NA World Service staff. The Florida Service Symposium has become expensive to host and the pandemic has made in-person events less well attended by professionals and members alike. Hotels, meeting space, food & beverage costs, travel costs, and declining donations have made this event cost prohibitive.

Financial Impact: The FRSC would have up to \$31,200 to not only assist in other similar events but have more funding available for assistance to areas and perhaps additional donations to support NA World Services.

Spiritual Impact: Letting go of the Florida Service Symposium would have a positive spiritual impact by allowing us to recognize our place in the fellowship as a whole and would allow others to benefit, grow, and have the first-hand experience that Higher Power has allowed us to have for the last 20 years.

Fellowship Development

FD Session started with Area Support following a brief orientation which covered the purpose of regional service, the weekend schedule, and an explanation of consensus-based decision-making (CBDM), as well as a follow-up on last Region's IDT's. Colin will acclimate to FD Leader, FD Co-leader position open.

Issue Discussion Topics

#1 = Liability Insurance (Forest Area)

Feedback: Some Areas/Groups are covered under the policy of the facilities in which they meet. FD/HRP will put together a FAQ for insurance.

#2 = Children in Meetings

Feedback: Some members feel unwelcome due to children, facility limitations (e.g., lack of separate rooms or playgrounds), and disruptive behavior. Some Groups have hired babysitters at meetings. Are children technically welcome at a 'closed' meeting? How do we support the chairperson in promoting an atmosphere of recovery, without pushing people out of meetings with too many rules?

#3 = Areas having their name connected to a convention. Suncoast Area raised concerns about how an area can protect itself when hosting a convention, particularly in terms of liability and the potential negative impact on local resources—such as the Activities Committee being drained or the convention becoming the Area's sole focus.

Feedback: The discussion emphasized the importance of obtaining separate convention insurance and highlighted potential challenges. Richard (Tampa Funcoast) offered to connect Suncoast with experienced convention planners for guidance. It was noted that Florida hosts a high number of conventions relative to its size, and possibly supporting existing conventions, rather than creating additional ones. A key concern was that events previously managed by Activities Committees often become convention fundraisers, which can lead to the collapse of the Activities group or make events unaffordable for members with limited means.

#4= A women's meeting becoming a vent-session about being targeted by predatory members at

other groups. Members are harassing women and selling drugs at meetings.

Feedback: Using Florida Region's "Predatory Behavior IP" as a resource, the responsibility of home groups to actively address such conduct, and the importance of personal accountability—encouraging members to speak up and take action when they witness inappropriate behavior. There was also discussion about involving law enforcement in cases of drug dealing or assault.

#5 = Concepts 6, 8, 10 & Inclusivity in Area Service (Greater Orlando):

Stefan (Greater Orlando) raised concerns about his area's leadership not being inclusive, not allowing members to ask questions of subcommittee chairs during area service, and members facing repercussions for raising grievances, feeling it violated these concepts. Discussion emphasized self-reflection, the importance of applying principles, and the potential for individual behavior to be the common denominator in conflicts. Focusing on what we truly have power over may be a simpler path to peace/understanding.

#6= Giving a clear NA message at H&I presentations. Ninnah (Bay Area) raised concerns about H&I panel members sharing inappropriately, including telling war stories, using non-NA language like "sober" or referring to "clubs" and "alcohol" without context, and promoting recovery without a sponsor.

Feedback: NAWS has videos on doing H&I presentations! The discussion emphasized that Area H&I subcommittees are responsible for properly training panel leaders, using resources from NA World Services (NAWS) and pairing new members with experienced ones. There was also a focus on the importance of gently correcting inappropriate sharing when it occurs. Overall, the group strongly emphasized the need for clear training and consistent messaging at the Area level to maintain the integrity of H&I efforts.

#7= Re-engaging older members with lots of clean time.

Feedback: Extending personal invitations to share at meetings, making service roles more accessible and appealing. Members explored reasons for disengagement, including health issues, feeling unheard, changes in the fellowship, and practical limitations like not being able to drive at night. The value of their experience was emphasized, along with suggestions like PR outreach and hosting events, such as brunches, specifically for longtime members. A member shared thoughts on maintaining balance between life and service. The group was reminded that complacency in service and recovery can be detrimental over time.

Good afternoon we attended the Marion County Children's alliance meeting which was held on May 7th and June 4th at the Mary Sue Rich center where we heard from spotlight speakers Tristan Baker Location leader of the Marion County Isaiah House who houses children that have been removed from their home for safety reasons, Karles Greenway CEO of Interfaith Emergency Services who provide full range of services and assistance for residents of Marion County that include food, clothing, shelter, housing, medication and other basic human needs, Renee & Evan Brandies of Herlow Helping Hands who provide essential drowning prevention pool safety resources, swimming lessons, and CPR training for families, and Laura Burgess Executive Director and Hilary Cabezudo Service Services manager of Pace Center for Girls which is a nonprofit organization where middle and high school girls find the support, guidance, and resources they need to thrive.
